REGISTRATION SUBMITAL OPTIONS

Forms must be received by Thursday in order to have cards for the coming weekend.

FINAL STAGE OF REGISTRATION

Once the registration form, payment and any other required documents (Youth to Senior, Liability Waiver) have been received and the Registrar has signed the Registration Form, the Registrar will e-mail the Player Card to the designated e-mail address in PDF format.

The Team Representative must then:

1. Print the Player Card on heavy weight paper, cut along dotted lines and fold
 2. *Place a current player picture (1" w x 1 ½" h) in the designated box on the card
 3. Have the player sign on the designated line and then laminate the card
- *Player pictures may also be electronically submitted in JPEG or TIFF format to snyder@wpsl.info, who will place the photo directly onto the PDF player card for printing. Make sure to indicate who each player is when submitting photos.

WPSL PLAYER REGISTRATION

Every player must be registered before they will be allowed to participate in league play.

- ❖ A laminated WPSL Player Card must be presented to the referee before each game.
- ❖ If a player plays a scheduled WPSL game without a Player Card, the player will be considered illegal and will be subject to Law C6 which states, "A team using an illegal player shall forfeit 1-0 all games illegal player(s) play in and will lose 3 points per illegal player per game."

- Check If Duplicate** – Mark this circle if this player is currently registered with USASA for the 2004-2005 registration season.
- Type of Registration** - Place a check mark next to the type of registration that's appropriate. Amateur Detention is a former pro now playing as an Amateur.
- Player Info** – Player name, mailing address, phone number, date and place of birth, citizenship, last 6 digits of player's social security number (*the Registrar may assign a player number if the player cannot provide SSN*) and email (*optional*).
- Amateur** – To register an amateur player with the stated team name.
- Player Release** – To release a player that has been registered with the stated team name.
- Player Loan** – To loan a player to another WPSL team for the designated period of time.
- Player Transfer** – To transfer a player from one WPSL team to another on the designated date
- Team Representative Information** – The team representative must state their full name and phone number and sign the form in acknowledgment of the registration, release, transfer or loan.
- Player Signature** – After filling out all required information and reading the release and disclaimer, the player must sign and date the form. If she is under the age of 18 a copy of the *Waiver and Release from Liability Form* signed by the player and her parent/guardian must accompany the registration. In some states, a *Youth to Provisional Senior Player Form* must also be submitted to the State Association.
- Registrar's Signature** – The Registrar will sign and date the registration form once all the required information and payment has been received. The player will be registered once the registrar signs.
- Submit To** – Submit the Registration Form and all other required documents to the Registrar either online, by mail or fax. If the form is faxed, the original must be kept on file by the submitting team.
